

For over ten years Dr. Kiener has worked at Maryville University of St. Louis, where he is a professor and director of Maryville's Rehabilitation Counseling program. Dr. Kiener stays active in the St. Louis community by being a member of multiple professional organizations including Missouri Rehabilitation Association and Inclusion Coalition for Employment. He teaches courses in research methods, counseling theory and critical thinking. In addition, he has twenty-seven publications including a coauthored book on strength based counseling and journal articles on career decision making, action research, counseling pedagogy, and active and dynamic learning strategies.
